**CONSTITUTION  
OF INDIA**


No. GHM-2009-66/NMK-102002-4165-N:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Revenue Talati Class III under the control of the District Collectors, namely:-

1. These rules may be called the Revenue Talati Class III Recruitment Rules, 2009.
2. Appointment to the post of Revenue Talati Class III shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall, -
  - (a) not be more than 25 years of age;
  - (b) have passed Higher Secondary School Certificate Examination conducted by a Secondary and/ or Higher Secondary Education Board or possess an equivalent qualification recognised as such by the Government;
  - (c) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
  - (d) possess adequate knowledge of Gujarati and/ or Hindi.

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967
4. The candidate appointed by direct selection shall be on probation for a period of one year.
5. The candidate appointed by direct selection shall, during his probation period be required to undergo pre-service training and pass the post training examination as may be prescribed by the Government.
6. The candidate appointed by direct selection shall, during his probation period be required to pass the qualifying examination for computer knowledge, in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
7. The Selected candidate shall be required to pass the departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

8. The candidate appointed by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.
9. A selected candidate shall be required to furnish a security and surety bond in such form, for such amount for such period as may be prescribed by the Government.
